Please remove any references to "Universal Provider Datasource" (UPD) from all providerfacing communications.
- CAQH is pleased to now offer a CAQH ProView participation seal. Participating
 organizations can display the seal to promote your organization's commitment to

- In fall 2017, CAQH formed an alliance with the American Dental Association to streamline the credentialing process for dentists, dental plans and employers. Starting on page 8, this Guide includes a section that explains more about this service, as well as content that may be used with dentists.

CAQH ProView is fully electronic and was developed to save you and your staff the time it takes to complete the lengthy paper credentialing forms needed for each healthcare organization with which you are affiliated.

CAQH ProView not only streamlines the credentialing process, it can also help improve provider directories, speed claims adjudication and simplify other business processes. Once your data has been entered, the solution enables you to easily update and attest to your information at any time. It is offered to you at no charge.

With CAQH ProView, providers and practice managers can:

- Self-report and electronically store practice and professional information through a single user-friendly process.
- Directly upload credentialing documents to improve the accuracy and timeliness of applications.
- Retain provider lists and information about multiple provider locations.
- Maintain secure control of each provider's professional information and authorize specified organizations to receive it.
- Reduce administrative burden and eliminate time-consuming paper submissions.
- Leverage the CAQH ProView profile to streamline directory maintenance and other processes that require practice and professional information.

Already Registered with CAQH ProView?

If you have already created your CAQH ProView account and are using the solution, please follow these tips to help ensure that your current information is accurate:

- Login to CAQH ProView to update and re-attest to your CAQH profile every 120 days.
- Replace expired documents with new ones.
- Leave no gaps in your work history for the most recent five years, or list the reasons for any gaps as appropriate; e.g., leaves of absence, maternity leaves, illness, etc.
- Ensure that a current copy of your liability insurance is attached to your CAQH profile.
- If you only authorize specific organizations access to your profile, please add [ORGANIZATION].

Getting Started with CAQH ProView

[ORGANIZATION] invited you to join CAQH ProView by sending a welcome letter via email [or mail] with your CAQH ProView Provider ID Number. Once you have received your ID Number, log in to CAQH ProView and follow the prompts to complete your registration.

If you cannot locate your welcome letter from [ORGANIZATION], new users also have the option to self-register through the <u>CAQH ProView Provider portal</u> [www.proview.caqh.org/pr]. Upon completion of the self-registration process, you will receive an email from CAQH with your unique CAQH ProView Provider ID Number.

First-time users should allow approximately two hours to complete your profile, or you can finish the process over several sessions. The menu prompts in CAQH ProView will guide you through each step. You control which organizations may receive your profile information – either by authorizing all of them or specific ones, including [ORGANIZATION].

CAQH ProView FAQs

The following Frequently Asked Questions provide basic information about CAQH ProView and how to access resources.

Who is CAQH?

CAQH, a non-profit alliance, is the leader in creating shared initiatives to streamline the business of healthcare. Through collaboration and innovation, CAQH accelerates the transformation of business processes, delivering value to providers, patients and health plans.

What is CAQH ProView?

CAQH ProView is an online provider data-collection solution. It streamlines provider data collection by using a standard electronic form that meets the needs of nearly every health plan, hospital and other healthcare organization.

CAQH ProView enables physicians and other healthcare professionals in all 50 states and the District of Columbia to enter information free-of-charge into a secure central database and authorize healthcare organizations to access that information. CAQH ProView eliminates redundant paperwork and reduces administrative burden.

How will [Organization] use my information?

[ORGANIZATION] uses the provider and practice information that you enter into CAQH ProView for credentialing and other business needs.

Does it cost anything to use CAQH ProView?

There is no cost for physicians and other health care providers to use CAQH ProView.

How do providers access CAQH ProView?

Providers can register online at <u>https://proview.caqh.org/pr</u>, or will receive registration instructions once a healthcare organization notifies CAQH that the provider needs to access the database.

Do providers need to complete their entire profile?

Yes. Providers must complete all profile questions; however, the system is designed to allow you to complete your profile over time. The CAQH ProView profile will present questions that are relevant to a specialty, provider type and practice location(s). You can save each page, stop at any time, and return later to finish the process. The entire profile must be completed prior to your verification of its accuracy, and before the organizations you have authorized can access it.

CAQH ProView Participant Seal



Value

The CAQH ProView participant seal indicates that your organization uses CAQH ProView to accept and/or capture healthcare provider self-reported professional and practice information. Displaying the seal affirms your organization's commitment to streamlining business processes, and reducing the administrative burden on providers and others in the healthcare system.

Ideas for Usage

- Post the seal on your organization's website. When possible, link to www.caqhproview.org.
- Include the seal on marketing and communications materials targeting healthcare providers.
- Incorporate the seal into your trade show display.

Display Guidelines

To preserve legibility and the integrity of the seal:

- Ensure minimum width is 2 inches or 188 pixels.
- Use a locked aspect ratio for any resizing.
- Apply padding (empty space) of at least 1/3 the height of the seal around all sides.

To reduce administrative burden for all dentists, the American Dental Association and CAQH have formed a strategic alliance that helps streamline the credentialing process for dentists, dental plans and employers. The ADA credentialing service, powered by CAQH ProView, enables any U.S. practicing dentists to enter their professional and practice information one time in an easy-to-use, fast and protected digital platform.

ADA is widely promoting this service to all U.S. practicing dentists, including its membership of 161,000 dentists. The number of dentists participating in CAQH ProView is expected to increase substantially, making it the leading industry source for dentists' credentialing data.

This alliance offers CAQH ProView participating dental plans several advantages:

- Real-time system validation of select dentist data against industry sources reduces incorrect data entry, increasing data quality and decreasing delays in data processing.
- Application programing interface (API) capabilities for access to the data through realtime web services.
- Secure electronic exchange of roster and dentist (extract) files, with roster exception reporting and customizable extract reports. Flexibility to receive dentist data in multiple formats: ASCII, XML or PDF.

Getting Started with the ADA credentialing service, powered by CAQH ProView

Prepare by reviewing the dental credentialing application <u>checklist</u> [http://www.ada.org/CredentialingChecklist] and gathering all required documentation prior to filling out your profile.

Any U.S. practicing dentist can get started in this service by visiting <u>www.ADA.org/godgital</u>. Once the terms and conditions are accepted, you are redirected to a Welcome Page. There, you will see certain pre-populated information from the ADA - or the information attested to previously - making it easier and quicker for you to complete and attest. First-time users can complete their profile in about an hour if the necessary items from the dental credentialing application <u>checklist</u> are readily available. The menu prompts in CAQH ProView will guide you through each step. You control which organizations may receive your profile information – either by authorizing all of them or specific ones, including [ORGANIZATION].

CAQH ProView eliminates redundant paperwork and reduces administrative burden.

Do I need to be an ADA member to participate?

No, any U.S. practicing dentist can participate. If you are a non-member and would like to get started, click <u>here</u> [https://ebusiness.ada.org/FirstTimeLoggingInPo3.aspx] to learn more about how to log in.

Does it cost anything to use CAQH ProView?

There is no cost for dentists or other healthcare providers to use CAQH ProView.

What does it mean to "attest" to my data in CAQH ProView?

After you enter your professional and practice data within CAQH ProView, you must personally attest to its accuracy.

I recently received an email from CAQH ProView, asking me to re-attest to my profile. What does that mean?

After you complete your CAQH ProView profile, the system will notify you every 120 days to re-attest that all information is still correct and complete – or to update it if not. This enables a dentist's contracted dental plans to access CAQH ProView profile information based on their different re-credentialing cycles. Please note that a dental plan or other participating organization will only be able to access your data once you have completed the re-attestation process, and only for those organizations where you have authorized access.

Does this mean I need to completely revise my profile every 120 days?

No, you only need to review the information already in your profile, update any information that has changed, and re-attest to its accuracy. In most cases, this will only take a few minutes.

Your Credentialing Checklist: Get Started Today

The ADA^{*} credentialing service, powered by CAQH ProView^{*} provides a digital alternative to the slow and cumbersome traditional paper method. To streamline your credentialing paperwork process and spend more time with patients, **any U.S. practicing dentist (ADA member or nonmember) can use this service**. Here is what you will need to begin completing the simple form at <u>ADA.org/godigital</u>.

These items are necessary to complete your credentialing application:

- \Box A copy of your state license.
- □ A copy of your professional insurance face sheet.
- □ Practice information.
- □ NPI Number.

You may also need the following*:

- □ Hospital affiliation information.
- □ A copy of your anesthesia license.
- □ A copy of your DEA (Drug Enforcement Administration) license.
- □ A copy of your CDS (Controlled Dangerous Substances) license.
- □ Medicare number.
- □ Medicaid number.
- □ BLS (Basic Life Support) certification information.
- □ ACLS (Advanced Cardiovascular Life Support) certification information.

*Depending on the state in which you practice, additional documents may be required.
