# CORE Operating Rules Recommended to HHS for Federal Adoption

### **NCVHS Recommendation to HHS**

On June 30, 2023,<sup>1</sup> the National Committee on Vital and Health Statistics (NCVHS) – a public advisory body to the Department of Health and Human Services (HHS)– recommended a set of **new** and **updated** CORE Operating Rules for <u>federal mandate under HIPAA</u>.<sup>2</sup> These rules modernize requirements related to the exchange of data for telehealth, prior authorization, complex benefit design and value-based payments.

If HHS supports the NCVHS recommendation, they will issue an Interim Final Rule (IFR) with a public comment period. Once HHS finalizes the rule, industry stakeholders have 25 months to meet the operating rule requirements.

# **CORE Operating Rules Recommended by NCVHS to HHS**

This set of new and updated CORE Operating Rules promote interoperability and ease the burden of workarounds and manual processes.

# Summary of CORE Operating Rule Requirements



# UPDATED CORE Eligibility and Benefits (270/271) Data Content Rule<sup>3</sup>

- Expands required service type codes and requires use of procedure codes.
- Indicates requirements for prior authorization.
- Enhances required details about benefit structure and patient financial responsibility.
- Facilitates telehealth coverage through required inclusion of CMS Place of Service Codes.

# NEW CORE Eligibility and Benefits (270/271) Single Patient Attribution Data Content Rule<sup>4</sup>

• Standardizes communication of a patient's attribution status to a provider under a value-based contract.



# Updated CORE Eligibility and Benefits (270/271),<sup>5</sup> Claim Status (276/277),<sup>6</sup> and Payment and Remittance (835)<sup>7</sup> Infrastructure Rules

- Increases weekly system availability requirements to 90%.
- Aligns connectivity requirements with most current version of CORE Connectivity.
- Supports a version-agnostic Master Companion Guide Template.

#### **UPDATED CORE Connectivity Rule vC4.0.08**

- Modernizes certification and authentication requirements, referencing X.509 and OAuth 2.0.
- Expands payload support to easily facilitate exchange of X12 v6020.
- Adds support for REST, strengthening application to HL7 FHIR-based APIs.

#### **Opportunities for Engagement**

The operating rules recommended for federal adoption represent an industry led, consensus-based process that included health plans, providers, government entities, vendors, clearinghouses, associations and others. Each requirement represents a step toward automation and the elimination of costly manual workarounds.
